## Description



Protek Wrap PC50H scrim is a 50 lb/ream (80 g/m<sup>2</sup>) natural kraft coated with 1 mil of white low density polyethylene reinforced with tri-directional scrim. The paper is saturated with Daubert Cromwell's nitrite-free ferrous volatile corrosion inhibitor (VCI) formulation. Also compatible with copper, copper alloys and aluminum, PC50H Scrim is designed for use as sheeting and interleaving between pallets and heavy steel rolls. It can be used when the application requires higher strength and barrier properties than standard VCI coated kraft paper. Also available in natural kraft, reinforced scrim with multi-metal corrosion inhibitors (Uniwrap® PC50MPI).

When the parts are unwrapped, the protective layer immediately begins to dissipate. Parts are clean, corrosion-free and ready to use. No further processing is necessary prior to use.
